



## San Diego Public Employee Benefit Association Open Enrollment Notes FY20

1. SAP/One SD online enrollment starts June 14th and continues through June 28th. Dates may be adjusted by the City.
2. The annual flex benefit for MEA-represented employees will be \$11,705.00, or \$487.71 per 24 cycle pay period.

4. SDPEBA will offer the following plans through flexible benefits to all MEA-represented employees: Sharp Classic, Sharp Select, Sharp Saver, MetLife Dental PPO, MetLife Dental HMO and VSP Vision.
5. A dependent is defined as your legal spouse, qualified domestic partner, child (biological, adopted, or stepchild under the age of 26), or qualified mentally or physically disabled child over the age of 26. No student verifications will be required. Once a child turns 26 years of age, they are no longer eligible but can continue coverage through COBRA. Please contact Risk Management for more information on qualified domestic partnerships and COBRA.
6. Employees must use the SAP/One SD employee self-service portal to enroll for benefits; no forms are available. For more information on how to access this system, please contact your payroll specialist or Risk Management. SDPEBA does not have access to this system and therefore cannot assist in navigating the SAP/One SD system.
7. If you are selecting MetLife Dental HMO for the first time, it is important that you select a dental office and insert that office code in SAP/ONE SD. If you do not enter a code, you will NOT be auto assigned to a dentist and this will cause delays in accessing your coverage.
8. If you are renewing your enrollment in Sharp Health Plan or MetLife Dental HMO plan and want to change your provider, you must do so directly with the insurance company. If you attempt to update that change in SAP/ONE SD, it will not be processed.
9. If you wish to add or cancel the Hyatt legal plan, you must complete a Hyatt Enrollment Form. This form is available online at [www.sdpeba.org/active](http://www.sdpeba.org/active).
10.
